**Subject: Correction in the particulars of the online Application Form of CUET PG – 2025.**

National Testing Agency is going to conduct CUET PG - 2025 between 13 March to 31 March 2025 at various examination Centres located in different cities across India and abroad in Computer Based Test (CBT) mode.

As per the information published in Information Bulletin and Public Notice, it has been decided to provide an opportunity to make corrections in the particulars of their respective Application Forms of CUET PG – 2025 as per the following details:

Please note that final correction shall be applicable only after payment of an additional fee if required. In case of change in Category, or PwBD, if there is an impact on the fee amount then the Candidate will be charged an excess fee as applicable. Excess payment made will not be refunded, if any.

All the registered candidates for the said Examination are advised to visit the website (<https://exams.nta.ac.in/CUET-PG/>) and verify their particulars. They are further advised to make correction/s in their particulars, in their respective Application Form, if required.

The candidates are allowed to make the corrections, latest by 12 February 2025 (up to 11:50 P.M.). Thereafter, no correction in particulars, whatsoever, will be entertained by NTA under any circumstances. The additional fee (wherever applicable) shall be paid by the candidate concerned either through Credit/Debit Card/Net Banking/UPI.

Universities who are desirous to participate in CUET (PG) – 2025 can register for participation till 07 March 2025.

Since, it is a one-time facility extended to the candidates to avoid any hardship to them, the candidates are advised to do the correction very carefully, as no further opportunity for correction will be given to the candidates.
